Addis, Margaret:

This scholarship is annually awarded to a student in good academic standing with financial need.

Alperin Family:

This fund, established by members of the Alperin family, is awarded annually to students based on scholastic achievement and/or financial need, with preference given to children of employees of Alperin, Inc., Triple A Trouser Mfg., Mayflower Mfg. Co., Gold Star Mfg., Astro Warehousing, or Alpha Warehousing.

Appleton, Prof. Anita:

The Professor Anita S. Appleton Scholarship was established by contributions from alumni and friends in honor of retired Keystone College professor and honorary alumna, Anita S. Appleton '90H. This scholarship is annually awarded to a junior enrolled in Keystone College's accounting curriculum who has a minimum grade point average of 3.20 and the greatest financial need as determined by the College's Office of Financial Aid and Planning.

The scholarship is renewable for a student's senior year based on continued excellent academic standing and financial need.

Minimum GPA to renew scholarship: 3.20

Barrett, Sr. Adrian IHM Leadership:

This scholarship is annually awarded to a student in good academic standing with financial need. Who also is from the Scranton area and dedicated to community service, in and outside of the Keystone College

Behrmann Family:

Established by former Keystone student, Nancy Behrmann, and her husband, John, a descendant of one of Keystone's founders, the Behrmann Family Scholarship is annually awarded to non-traditional students.

Boehm, Edward & Regina:

The Edward G. and Regina E. Boehm Scholarship was established by Keystone College president, Edward G. Boehm, Jr., and first lady, Regina. This scholarship is annually awarded to a student who demonstrates financial need and is in good academic standing.

Briggs, Margaret:

The Margaret Briggs Foundation Scholarship fund was established by the Margaret Briggs Foundation and is given annually to incoming first-year students from Lackawanna County or one of the surrounding counties. The scholarship is renewable to sophomores who maintain satisfactory academic standing.

Brooks, John H.:

The annual earnings of the John H. Brooks Memorial Scholarship, established by the children of John H. Brooks, longtime trustee and supporter of Keystone College, are awarded to a deserving student.

Brown, F.L.G.:

Student in good academic standing with financial need. Priority will be given to a U.S. Navy veteran. If no Navy veterans meet the criteria, the scholarship may be awarded to any veteran or family member (wife or child) in good academic standing with financial need.

The scholarship is applied directly against students' tuition, available beginning in the freshman year and can be renewed annually.

Minimum GPA to renew scholarship: 2.5

This scholarship is annually awarded to a student enrolled in the College's math and science program who is in high academic standing with financial need.
